Dexter To Huron-Dexter Metropark Grand Opening Report



From the Summer Washtenaw Bicycling & Walking Coalition Newsletter...

Dexter Trail Opening is Celebrated with 10k Run (By Larry Deck) - The grand opening of the newest segment of the Border-to-Border Trail was celebrated on June 7th with a 10k run along the trail. Starting near North Territorial Road, runners followed this scenic trail segment near the Huron River through Hudson Mills Metropark to Dexter. Entertainment and refreshments awaited the runners at Mill Creek Park in Dexter. This multi-use trail, completed last fall, has a 10-foot asphalt surface except for 14-foot boardwalk sections through wetlands.

The Huron-Clinton Metroparks, the Washtenaw County Parks and Recreation Commission, and the Village of Dexter organized the event. Those agencies partnered with the Washtenaw County Road Commission, the Washtenaw Area Transportation Study, the Michigan Department of Transportation, and the Michigan Natural Resources Trust Fund over a period of several years to construct this trail. WBWC has participated in the discussions that led to the development of the trail.

Ypsilanti Trail Segment

Construction is still expected to begin by the late summer or early fall on a B to B bridge from Riverside Park south to the eastern end of the Michigan Avenue bridge across the Huron River, as well as constructing a permanent (hard surface) trail along the north shore of the Huron River from Michigan Avenue south/southeast to Grove Road (for a map of the planned trail, <u>click here</u>). At Michigan Avenue, there will be a HAWK signal is basically a stoplight for motorists to give non-motorized a way to cross a road. Relating to the Ypsilanti Trail, if was recently announced that the City of Ypsilanti did receive a Federal Transportation Alternatives Program (TAP) funding request to replace the sidewalk along Grove Road with a wider non-motorized path that would continue the B to B trail south closer to the I-94/Grove Road bridge. Quick Updates

Dexter To Dexter-Huron Metropark Trail "Gap"

There currently is a very short "gap" of the Border To Border Trail from the completed off-road Trail in the Dexter-Huron Metropark to Central Street in Dexter that unfortunately is still waiting on construction due to negotiations with a landowner. The Washtenaw County Parks & Recreation Commission, however, is diligently

working on the completion of this segment, but like other things in life, little problems sometimes take a longer time to work out.

Grove Road B to B Reconstruction

A rebuild of the B to B in Ypsilanti Township is still set to begin later this summer. Some sections of the formal off road Trail will be moved to the north side of Grove Road due to narrow easement sections on the south side of the road.

Northwest Trail Activity

On the northwest segment, the Washtenaw County Parks & Recreation Commission has submitted a grant application with the Michigan Department of Natural Resources to further move along a route would extend the B to B Trail north to Livingston County and then even further north to meet up with the east-west Lakeland Trail (www.hamburg.mi.us/lakelands_trail_state_park). The Lakeland Trail is intended to be at some time to become a part of the eat-west cross-Michigan Great Lake to Lake Trail (http://bicycletouringroutes.com/section.php?sectionid=1).

Quick Trail Winter Use Survey - Your Help Needed!

Again this year, the Friends of the Border To Border Trail will work to try and keep the Trail open and plowed from Ann Arbor to Ypsilanti as well as Dexter north into Hudson Mills Metropark. Sometimes, however, when meeting with entities that have B to B segments going across their property, the notion comes up that "nobody uses" the Trail in the winter (despite loads of footprints and bike tire tracks in the snow).

Winter outside recreational (and non-motorized transportation) opportunities are so very important too. Not only does getting outside and walking/biking help us keep fit, but also does loads of good mentally to break what is known as "cabin fever".

With this in mind, a very simple survey is posted on the Friends webpage that winter users of the Trail are urged to fill out. All data is anonymous and will be used in "making the case" for agencies to keep the Trail open and plowed in the winter. Ann Arbor & Ypsilanti Local Elections Survey

Before the recent August local Ann Arbor/Ypsilanti primary elections, the Washtenaw Bicycling and Walking Coalition (www.wbwc.org) sent out a candidate survey that did contain questions relating to the Border To Border Trail. Specifically Ann Arbor candidates were asked how they would fill in trail gaps (Bandemer Park and Huron River Drive, Maiden Lane & Fuller Road areas) and Ypsilanti candidates were asked how they would develop a plan for continuing the Border to Border Trail northwest from Frog Island Park. Volunteers Needed To "Adopt" Trail Segments

The Friends of the Border To Border Trail is looking at starting to set up a list of volunteers who would be willing to "adopt" a section of the Border To Border Trail. Volunteers, who routinely use a specific B to B segment on a regular (2-4 times a month) basis would be asked to perform the following...

- Pick up trash (although for the most part, the B to B stays remarkably trash-free).
- Report serious problems (potholes, major downed branches, missing direction signs, etc.).
- During the "green" months, trim back (with hand-tools) vegetation tending to obstruct the trail.

Currently, B to B segments needing "adoption" would include...

- Grove Road (Ypsilanti Township).
- Eastern Michigan University
- St. Joseph Mercy Hospital/Washtenaw Community College area.
- Dixboro Bridge area
- Gallup Park (Ann Arbor)
- Central Ann Arbor (Riverside Park, Bandemer Park)
- Dexter (Dexter-Huron Metropark, Mill Creek Park to Hudson Mills Metropark)
